# Rules: 2011 California QSO Party (CQP) Sponsored by the Northern California Contest Club

Begins: 1600 UTC - 1 October 2011 Ends: 2200 UTC -2 October 2011

## **OBJECT**:

Stations outside of California work as many California stations in as many CA Counties as possible.

Stations in California work everyone.

### **EXCHANGE**:

- 1. California stations send QSO number and County.
- 2. Stations outside of California send QSO number and State, Canadian Province, or "DX".

Note: California stations must log all CA contacts with the 4-character county abbreviation, everything else as two characters, including "DX" for all stations outside of the U.S. and Canada.

## **QSO POINTS:**

Each complete non-duplicate Phone (SSB or FM) contact is worth 2 points. Each complete non-duplicate CW contact is worth 3 points. <u>Although there is no credit for duplicate contacts</u>, there's no penalty either, so please do not remove them from your log.

#### **MULTIPLIERS:**

A. California Stations:

Count U.S. states (50) and Canadian Provinces (8): QC, ON, MB, SK, AB, BC plus:

- MR Maritime provinces plus Newfoundland and Labrador (NB, NL, NS, PE)
- NT Northern Territories (NT, NU, YT)

Maximum of 58 Multipliers

Note: Although the "CA" abbreviation is not used as a multiplier in this contest, the first valid CA county logged will count as the multiplier for California. California stations must log all CA contacts with their 4-character county abbreviation; everything else as two characters, including "DX" for all stations outside of the U.S. and Canada.

## B. Non-California Stations

Count all 58 California Counties for a maximum of 58 multipliers.

#### **SCORE:**

The total score is the total number of QSO Points multiplied by the total number of multipliers (58 maximum).

**MODES:** CW, PH (PH = SSB or FM)

**BANDS:** 160, 80, 40, 20, 15, 10, 6, and 2 meters. WARC band contacts do not count.

Suggestions: CW on 1815 and 40 kHz up from band edge. Phone on 1845, 3850, 7230, 14250, 21300, 28450. Try CW on the half hour; 160 meters at 0500 UTC; 80/75 meters at 0300 and 0700 UTC.

VHF: Look for 2M FM activity on 147.54. For 6M and 2M SSB/CW, first try 50.135 and 144.210. If no activity, make a short call on 50.125/144.200 then QSY back.

#### Notes:

- 1. All CW contacts must be made outside the Phone sub-bands except for 160 meters and VHF. MCW is not permitted.
- 2: Stations may be worked once on CW and once on Phone per band.
- 3: Phone is defined as SSB or FM. Stations cannot be worked on SSB and then again on FM on the same band.
- 4: All contacts must be Simplex.

Note: Off-times must be a minimum of 15 minutes and clearly marked in the log. Use of spotting nets (operator arrangements involving assistance through DX-alerting nets, PacketCluster, CW Skimmer, self spotting, etc) is not permitted. An SO entry will be reclassified as Multi-Single if any assistance is used, but will be allowed to operate the full 30 hours. SO2R operation is perfectly acceptable.

Select One If It Applies:				
California County Expedition (CCE)	A County Expedition is an operation from a temporary location using temporary antennas installed for the contest period, using temporary antenna supports (natural supports like trees permitted). CCE stations send only ONE county per exchange, including those on a county line.			
Mobile	A station that is self-contained, capable of legal motion (street, water, or air) while operating, motion optional. Note: California stations that change counties are considered to be a new station and may be contacted again for point and multiplier credit.			
School	School entries must indicate such on the summary sheet, use the appropriate school call sign and operate from the campus station if one exists. Any school club members may operate including students, faculty, staff, and/or alumni.			
Novice/Technician	A Novice/Technician entry must use a			

	Novice/Technician call sign and operate exclusively within the Novice/Technician bands.
YL Operator	YL entries should indicate such in the soapbox field to be eligible for the Top YL awards (for both CA and non-CA YL Operators)
Youth Operator	Youth entries should indicate such in the soapbox field to be eligible for the Top Youth awards (for both CA and non-CA Operators). "Youth Definition" = 18 years old or younger [in his/her local time zone] on the last day of the contest.
Club Competition	Club Competition is encouraged. Club members can submit their logs for the club competition by entering the club name in the Cabrillo file 'club' field. A Club is defined by the ARRL competition rules. NCCC, SCCC, NCDXC, and SCDXC are not eligible in the club competition.

# **ENTRIES:**

Entries must be submitted no later than **Monday, October 31, 2011.** Please only submit your log by ONE of the following two methods. If you have any difficulty with either method, please email a description of the problem to: logs@cqp.org.

## **CONTEST LOG SUBMISSIONS:**

- 2. Logs can also be submitted by e-mail to: <a href="logs@cqp.org">logs@cqp.org</a> Electronic logs should be named with your call (e.g., AD6E.SUM, AD6E.LOG, etc.). All files should be zipped into one file such as AD6E.ZIP before attachment. Cabrillo style format is preferred but not mandatory. CT logs must include the summary file. Duplicate QSOs are not counted for points and will not result in penalties, but they will be counted for multiplier credits. Separate dupe sheets for electronic logs are waived.
